There are still some anti-social behavior issues around Poppy Mead and Bluebell Road area of Park farm. I am patrolling the area regularly. I have also asked for some assistance from my colleagues on the Tasking Team to patrol the area too, when I am off duty.

Many of you may have seen on the Meriden News a few weeks ago, Op Jump. This was to educate children in schools about knife crime. This had a massive impact on the 8000 school pupils, their teachers and the community.

I have attended a few courses over the last couple of weeks, including Mental Health and Suicide awareness.

Police Community Support Officers will be attending the Furley Park School fete on the 29th June 2019.

I have been on the scene of a ram raid at the village shop in High Halden. I was also on the scene of the ATM attack on the Co-op on the Faversham Road, Ashford. I am pleased to say within 24 hours 6 arrests were made.

Across the Ashford district, there has been a spate of car windows being smashed and bags stolen. Please can I remind you all to keep your valuables and bags out of sight when you park your car?

Finally, all the PCSOs did a weekend Op in Stanhope recently with regards to anti-social behavior in this particular area. We like to be seen out and about, reassuring the public and engaging with any nuisance youths

COMMENT: THIS HOUSE IS IN A PROMINENT POSITION ON CHURCH HILL

I CAN SEE NO REASON TO OBJECT TO ANY OF THE ADDITIONS TO THE BUILDING WHICH IS EFFECTIVELY BRINGING IT UP TO MODERN STANDARDS.

THE FORCOURT APPEARS TO BE WELL THOUGHT OUT AND PROVIDES GOOD PARKING ARRANGEMENTS OFF THE ROAD.

HOWEVER TO RAISE THE FRONT AND SIDE WALLS FROM 625MM TO 1800MM SEEMS EXCESSIVE TO ME EVEN TAKING INTO ACCOUNT THE QUALITY OF THE PROPOSED MATERIALS.

THEREFORE SUGGEST THAT THIS APPLICATION COULD BE SUPPORTED IF THE FRONT WALL IS CONSIDERABLE REDUCED IN HEIGHT THE APPLICANT MAY WISH TO RECONSIDER THIS APPLICATION
