4. Open Forum

A Discussion on Court Lodge, Kingsnorth Green and Chilmington Green Master Planning took place with a projector showing report which had been created by James Ransley

AB suggests Opening statement on the response to Ashford Borough Council includes the following:

- Increase traffic flow generated by these sites.
- We don't think these applications should be considered until the master planning exercise has taken place
- We are concerned by the significant increase in dwellings proposed on the site with no specific justification other than an element of flexibility and we suggest flexibility of 50 additional units is enough.
- Infrastructure, the assessments that have been done on this specific site have not considered new developments that have happened since and the Master Planning or coordinating those other sites.
- loss of Discovery Park

SD Opening bullet point needs to lay the foundation that it's not going to work, and the master planning needs to be an integral part of each of the three individual plans going forward.

AB to be added as a bullet point - we don't think these applications should be considered until the master planning exercise has taken place – all agreed

PB the loss of Discovery Park (Chilmington Green) – added as a bullet point

PM concerns around increased traffic flow

AB Increase traffic flow generated by these sites to be added as 1st bullet point

5. Community Wardens and PCSO Reports.

AB reads report on behalf of PCSO sent by e mail prior to meeting:-

Hello Everyone,

On the evening of the 17th January a meeting of the Council, the Police and some residents of Chestnut Lane was held at the Civic Centre, Tannery Lane, Ashford. This meeting was to discuss the ongoing white van parking issues.

It was clearly explained to the residents exactly what the Council and the Police are able to do and not do. SGT Bloomfield advised that residents should report to Police at the time of any alleged offences, not after the event.

There are also issues regarding noise. Some vans are started up in the early hours of the morning, disturbing residents with radios and reversing noises. The Council has sent out diary sheets to residents affected, to be completed and returned to the Council. One of the tenants responsible for causing such issues is being evicted in mid-February, which hopefully will ease some of the problem.

- Following on from discussions on Court Lodge, PB and MA will be meeting with Kent Highways on 19th March to get feedback from them.
- Nothing in KCC budget for Pound Lane link road. Orchard Way is still in KCC budget.
- A28 construction is in the 2020-2021 KCC budget

- Has asked for a bollard to go in on the footpath on the link road (bus only link road) between Bridgefield and
 Finberry due to drivers driving on the footpath to get around the concrete barriers.
- ABC requesting a camera to be put on Accommodation Bridge. Reported anti-social behaviour around the Accommodation Bridge in Bridgefield over the last 2 years that has been telephoned and reported to the police is only 6 reports.
- Has a meeting on play areas in general so will report back with details.
- KCC now have a reporting portal for bus drivers.

Cllr Neil Shorter presents his report:

- Re-enthesis's how important it is to use the 'Report It' app.
- Budget goes to cabinet this week. Comments on the budget can still be made.
- Proposal being discussed for a solar park down Tally Ho Road on the old Scout Field, not in a planning phase but being floated for consultation.

Cllr Stephen Dehnel presents his report:

• Will be driving an advertising media campaign through the compliance and enforcement board to get message out regarding 'Report It' anti-social behaviour across the spectrum.

AB Kingsnorth will be participating in the national street cleaning campaign. Will come back to PB and NS with dates once agreed.

- KALC Planning Conference. AH and MR would like to attend, money in training budget all agree. MR to book.
- Ashford campaign on community clean-ups running from 22nd March 23rd April. We will be participating.
- Dave and Matt have agreed to complete risk assessments for the litter pick. Trevor Measday is happy to lead on
 it. AB recommends we get involved in it and set a budget of up to £200 to cover any administrative expenses
